DAY 1 SAT AUG 01 DEPART USA / ARRIVE IN LIMA, PERU

Board your flight to Lima. Upon arrival, you are transferred to your hotel.
Accommodations: Hotel El Patio Miraflores

DAY 2 SUN AUG 02 LIMA / CUZCO / SACRED VALLEY

After breakfast, transfer to the airport for the flight to Cuzco. Upon arrival, you will be met and assigned to your private touring vehicle. The driver and vehicle will be at the group's disposal for the next 8 hours. Lunch at Sol y Luna is included today. Tonight, dinner at your hotel is included.
Accommodations: Hotel Posada del Inca Yucaj (B / L /D)

DAY 3 MON AUG 03 SACRED VALLEY

Enjoy breakfast at your hotel. The driver and vehicle will be at the group's disposal for 8 to 10 hours today. Entrance to Ollantaytambo ruins is included.
Accommodations: Posada del Inca Yucaj Hotel (B/D)

DAY 4 TUE AUG 04 SACRED VALLEY

Enjoy breakfast at your hotel. The driver and vehicle will be at the group's disposal for 8 to 10 hours today. Entrance to Pisac ruins is included.
Accommodations: Posada del Inca Yucaj Hotel (B/D)

DAY 5 WED AUG 05 SACRED VALLEY / MACHU PICCHU

Enjoy breakfast at your hotel. You will transfer to the Ollantaytambo station for the Vistadome train to Aguas Calientes. Upon arrival, ascend to Machu Picchu by shuttle bus. Entrance to Machu Picchu and shuttle bus (SIB) up/down to the ruins are included. This evening, dinner at Indio Feliz is included.
Accommodations: Machu Picchu Inn (B / D)

DAY 6 THU AUG 06 MACHU PICCHU / CUZCO

Early risers may explore Machu Picchu at sunrise, with the rest of the morning free (entrance is included as well as the shuttle bus -SIB- up/down). Perhaps a climb up Wayna Picchu for hiking enthusiasts. This afternoon, travel back to the Ollantaytambo station by train and transfer to Cuzco and your hotel by bus.
Accommodations: Eco Inn (B/D)

DAY 7 FRI AUG 07 CUZCO

Enjoy breakfast at your hotel. The driver and vehicle will be at the group's disposal for 8 to 10 hours today. Entrance to the archaeological park housing the ruins of Sacsayhuaman, Tambomachay and Kenko is included.
Accommodations: Eco Inn (B/L)

DAY 8 SAT AUG 08 CUZCO

Enjoy breakfast at your hotel. You will have a full free day to explore Cuzco on your own.
Accommodations: Eco Inn (B)

DAY 9 SUN AUG 09 CUZCO / LIMA

Enjoy breakfast at your hotel. This morning, transfer to the airport for the flight to Lima. Upon arrival, you will be met and assigned to your private touring vehicle. Entrances to the Larco and Archaeological Museums are included. You will have lunch at La Dama Juana restaurant this afternoon. After dinner (on your own), you will transfer to the airport. (B/L/ D)

DAY 10 MON AUG 10 DEPART LIMA

Your homebound flight is scheduled to depart from Lima at 1:40 a.m. and return to Los Angeles at 8:15 a.m. the same day. You will take with you fond memories, images of the beautiful scenery and the many mementos found along the way.
